TERMS OF CHARTER

I hereby acknowledge that SingaporeSailing, the National Sailing Centre, the Laser International Class Association, Constant Wind Pte Ltd and all officers, members and volunteers working under their auspices do not accept liability for loss of life or property, or personal injury or damage caused by or arising out of the 2006 Laser Asia Pacific Championship and Singapore Laser Trophy (the 'events'), and that I am chartering the Laser and take part in the championship entirely on my own volition and at my own risk. I hereby indemnify and agree to keep indemnified the abovementioned from all claims that may arise from any act or omission in the conduct and organization of the events.

1. All competitors must provide their own sail, cordage (Outhaul, Cunningham, kicker, traveler, mainsheet), boom vang, mainsheet block, traveller blocks, tiller and extension.
2. Damage deposits (less and deductions for damage) will be refunded at the end of the Championship from Constant Wind Pte Ltd.
3. Hirers are to make good any damages or loss to any of the charter equipment, including scratches and bent spars; boat damage will be assessed on case to case basis for the repair / replacement cost will be deducted from the damage deposit. If the cost is above the deposit the outstanding amount must be duly paid upon returning of the equipment.
4. All masts have been checked to ensure that they are within the design tolerance. Competitors are reminded that mast may be more likely to bend if high boom vang loadings are used.
5. No changes, additions, or alterations to the spars, hull and fittings shall be made except as follows:
A compass, wind indicator and tell tales supplied by the competitor may be used provided that they can be fitted without piercing or otherwise marking the hull or spars.
6. Wet or dry sanding of the hull or any other equipment is prohibited.
7. The use of waxes, polishing compounds or similar is prohibited. Competitors may wash their boat with detergent and water.
8. Plastic tape or similar may be used in accordance with the Class Rules.
9. The boats will be supplied with new deck cleat fitting with cleats and the new deck block fitting WITHOUT deck blocks. No fitting may be removed. Even if it is subsequently replaced, and no repairs may be undertaken without the permission of the Organising Committee. Note: All the fittings are sealed with silicone during manufacture.
10. The use of the charter boats may be withdrawn if, in the sole opinion of the Organising Committee, a competitor breaks any of the conditions of the charter or treats

or handles a charter boat without care or in a manner which causes or is likely to cause damage to the boat.

I understand and agree to abide by the Terms of Charter as detailed above and I understand that the submission of this form via email will be taken as acceptance of the Terms.
